CEU credit: Continuing education units (CEU) are offered for various professional development courses. CEU are used when employers, relicensure agencies, school districts and other authorities require a specified number of hours of noncredit study for career advancement. CEU are not accepted for academic credit and do not apply toward degree programs or meet teaching credential

<ul style="list-style-type: none"> • What unit should I choose? • How many units do I get? 	CEU cannot be applied towards a degree. If you are earning units for an increase in pay, the CEU may be acceptable. (This may require your employer's prior notice.)
<ul style="list-style-type: none"> • How much does it cost? 	The cost for 1 continuing education unit (CEU) is \$75.00.

Fill out and submit the CSUCI Extended Education enrollment form and use credit card to pay. *Spring 2025 course numbers are valid from 1/15/2025 to 5/23/2025. Students completing the training after May 23, 2025, must register for Fall 2025 credit.
<ul style="list-style-type: none"> • Why do I have to give my SSN? 	CSUCI requires a Social Security number for registration in a course.
<ul style="list-style-type: none"> • What do I have to do to in the course? • What are the requirements for the course? • Do I have homework? 	Attendance at the one (1) day training is required. You must <u>sign in and out</u> at the training. The sign in sheet will be sent to CSUCI to verify attendance. Participants are not required to turn in an assignment to receive CEU.

Professional growth is something that an agency approves for each participant. A certificate is available to each attendee to verify attendance. CEU are true college credits. Participants registered for the course will receive a separate certificate.
